**Stilwell Schools Special Services: Part 2** 

### **Meet The Staff**

Stilwell Schools Special Services plays a vital role in educating those students who have special needs, who most likely would otherwise "fall through the cracks." In last week's issue, we interviewed Director Rachelle English. This week we will meet some of her outstanding staff members.

Margie Littledeer, who serves as a 5th thru 8th grade Reading and Math teacher, plans to retire after this year. She has poured her heart out for her students over the past 20 years. Margie comes with high energy and motivational strength that reaches the most reluctant students. Not one to sit around, she said she will spend her time developing hands-on life skill lessons that she plans to share with former and future pupils, during her retirement.

Tonya Means, with 23 years, 12 years in Stilwell, Special Ed under her belt, serves as Special Services Coordinator where she directs disability testing for over 300 students for determining Individual Education Plans (IEP). She is also in charge of medical billing and coding for Medicaid recipients for things like occupational, physical and speech therapy. She told me that she was drawn into Special Ed by a special needs child while interning at Rocky Mountain.

Maria Verduzco, who is working as a counselor under a Counselor Core Grant, handles re-hab counseling. She is pursuing her certification at NSU. Part of her activities includes working with the food drive, the food bank and Catholic Charities of Eastern Oklahoma. Her fluency in Spanish comes into play for the Spanish speaking students. Maria is also available for driving a blind student to Muskogee School For The Blind, as well as a deaf student to Sulphur. One might add that Special Services is much misunderstood by the general public.

Next, we have Charity West. Charity joined the staff during the outbreak of Covid. She had been a

classroom teacher in AP English at Stilwell High School. She became the Virtual Instructor where she serves 63 students from middle to high school who are dealing with various issues. She said she loves her new job that allows one-on-one interactions that are bringing results.

And then there is Jane Rhoades. Jane is the Coordinator of Full Service Community Outreach, which is funded by a Federal Grant. The mission of this program is to provide evening parent-student events, among which are scholarship writing, gun safety, puzzles, health, teen violence. These events serve as a liaison between the schools and students' families. Working at the Elementary level is Rhea Toney; for the Middle Schools we have Joshua Luck and at the High School there is Maegan Parks.

Working as a Speech Pathologist is Fiona Moldrup, who is assisted by Tina Martinez, the mother of the outstanding Football and Basketball athlete, Juan Martinez. Tina has her sight set on becoming a Speech Pathologist. Meanwhile, she assists Fiona with state required vision and hearing screening for 1st and 3rd graders. She is currently attending NSU for her Special Education degree. She said she is committed to Special Ed as a lifetime endeavor.

Finally, we have met the outstanding dedicated staff that make Stilwell Schools Special Services such a success. Without this branch of our education system, many students would find themselves without proper education that helps them overcome their disabilities and gives them a bright future.

This would become the third time this season that the two teams had tussled. Stilwell had won both of the previous contests. This night would bear the same fruit for Stilwell. In the opening game, the Lady Black Diamonds kept the game close in the first quarter with the Indians taking a 14-11 lead. Snowda Watie led the way with 7 points. In Quarter 2, the roof caved in on the Lady Black Diamonds, as they failed to score a single point as Watie continued her point barrage, adding 9 more to

her eventual game total of 19. Stilwell led 31-11 at the half. With a relentless stifling full-court press that yielded multiple turnovers, the Lady Indians' pressure was too much for Sallisaw. Final Score: Stilwell 57 Sallisaw 21 The first rung of the ladder to the Gold Ball has been climbed as the Lady Indians claimed the District championship with an 18-5 season record. ### THE RIGHT TO KNOW

Physical decline is something none of us are immune to, at some time in the future all of us will experience a reduction in mental and physical ability. From personal experience in my own family, the reduction of mental ability is far worse than the physical decline. I have seen people that remain mentally sharp as a tack up to the point of death, but for some, when the mental ability declines, some hard choices must be made. 
