MEMORIES OF FARM AND FAMILY

I remember the days before "running" anything. There wasn't running water, indoor plumbing, or an in-ground septic tank for waste removal. Running water was performed by pushing open the screen door with one hand while holding an empty water pail, then drawing up the roped bucket with fresh water and emptying it into the enamel container. Even the 15-foot well was hand-dug by my Uncle Ernest, husband of Granny's oldest daughter. The indoor plumbing consisted of a "slop jar" which was white enamel with a lid edged in

red. It was my job to run it out to the hog pasture and throw it into the grass. The daytime toilet was a wooden outhouse about fifty feet from the back of the house. Positioned at the edge of the woods, it was a wooden two-holer, unpainted as I remember, with a door sporting a sun and moon high on the front wall. Guess this was for ventilation. Don't remember any toilet seats, BUT I do remember checking to see if there was anything lurking below! The next update was an adult potty chair with arms in Granny's room. The septic tank

and running indoor plumbing would come when my parents bought the farm from the siblings after my grandmother passed. In 1980 they moved in and added two bathrooms, a huge kitchen, a small bedroom with multiple closets, a massive den, and a west door. The finishing touch was moving the huge flat rock from the back door to the front porch landing. Each generation has added something to the 95-year-old homestead. The flat rock stands monument to change and survival of the family home.

In November, President Biden emphatically said he would change “nothing” in his agenda. His budget this week will prove that point. More government. Less freedom. Slow economic growth.

Funding the Woke Agenda at Taxpayer Expense

The responsibility to spend the taxpayers’ money is the key to everything the government does. The Constitution makes clear that the government is supposed to only spend funds on things that benefit all Americans in carrying out the enumerated powers.

Unfortunately, the budget has been used to fund the controversial and partisan policy agenda and the institutions of the progressive movement, at the expense of the American people.

As the budget has grown, government has too, with politicians and bureaucrats exerting control over the most personal aspects of the lives of everyday Americans. The American people are fed up with their tax dollars being used against them. Injecting Divisive DEI Into Every Aspect of Government

President Biden has attempted to inject controversial and divisive diversity, equity, and inclusion (DEI) race, sexual orientation, and gender identity- based policies through every aspect of the federal government.

These policies are antithetical to the very founding of our nation, which is based on the principle that “all men are created equal.”

Federal agencies have been required to develop “Equity Action Plans” to describe how they will take into account race in reallocating taxpayer funding through contracts and grants to politically favored groups. For years, the Department of Justice (DOJ) and the Federal Bureau of Investigation (FBI) have been working with social media companies, notably Twitter, to censor Americans.

Since October 2019, the FBI has paid Twitter over \$3.4 million for processing requests to access stored communications data. However, the specific nature of these requests is unknown, although it does raise questions about how much the FBI is shelling out to other companies to access Americans’ private information.

An Intrusive and Hijacked Education System

President Biden signed an executive order explaining how the country is plagued by “systemic racism” and “deserves an ambitious whole-of-government equity agenda which led to a rule that would award millions of dollars in grants that prioritize the belief that America is systemically racist.

The Department of Education is distorting Title IX based on sexual orientation and gender identity, allowing biological males to compete in women’s sports, forcing states and localities receiving federal funding to implement the Department of Education’s guidance or risk losing federal funding.

Last year, the Department of Education requested \$161 million for the Department’s Office of Civil Rights, a 23 percent increase over FY 2021’s level. Climate Extremism and an Overreaching EPA

Instead of fighting rising energy costs, President Biden approved funding for new luxury electric vehicles of wealth families. These tax credits would cost taxpayers \$7.5 billion.
