District 27 DA Addresses Republican Party Meeting

N. Jack Thorp is the District Attorney for District 27, a district which encompasses 4 Counties: Adair, Cherokee, Sequoyah and Wagoner. On Monday, October 23, at 6:30 pm, Mr. Thorp was the featured speaker at the Adair County Republican Party meeting held at the Stilwell Public Library meeting room. In front of a strong turnout, Mr. Thorp covered a lot of subjects with which his office deals on a daily basis. He began his talk by saying, "I have been a prosecutor for 25 years. I have always wanted to be a prosecutor." After earning his law degree from U of Arkansas, he prosecuted for 6 years in Arkansas before deciding to come to Oklahoma. He joined the DA office in Adair County as an ADA (Assistant District Attorney) working with DA Brian Kuester. He ended up being appointed as the DA when Kuester was appointed by Donald Trump as a U.S. Attorney. Mr. Thorp has since been elected twice. He spoke extensively about medical marijuana. His office, along with other agencies, recently shut down an illegal grow operation



outside of Westville where 600 pounds of pot were seized. Investigations revealed that this operation was tied to a criminal mob out of New York. As a matter of fact, Mr. Thorp said that medical marijuana has attracted many nefarious actors and along with loose regulation, e.g., THC content can be as high as 80%, has presented enormous law enforcement challenges. He stated that schizophrenia, related to strong pot use, is on the rise. According to Mr. Thorp, folks in Colorado, where pot is legal and strictly regulated, have dubbed Oklahoma as "The Wild West."

Of perhaps even greater concern is the amount of Fentanyl readily available on the street. Thorp said,


Cave Springs Hornets: 8 Man Football


